Letter from Executive Director, Alex Doolittle

Dear Supporters of SCLC,

2015 was a year full of success for the projects, clients, and overall health of the Seattle Community Law Center. More than 90% of the people we served this year defined the outcome of their legal struggle as "successful."

A client, Willie Holmes, exemplified this success when speaking at 2015's LOL for SCLC fundraiser. Mr. Holmes claimed that the legal support he received from SCLC was essential for staying off the street, and that in his deepest moment of doubt, the service of our staff and volunteers saved his life.

His message was a resonant way to give back to our organization, and with the support of our community of donors, we raised more than \$60,000 in one night—making the 2015 LOL for SCLC our most successful fundraiser to date. This support and mutual passion fuels our work, and when addressing big issues of stable housing, access to Medicaid & Medicare, debt relief, and economic stability (at least \$733/month to live on), our donors make big outcomes possible.

When a person can afford to house, feed, and clothe themselves, it reduces their dependency on the costly administrative and emergency services of our local governments, and empowers them to support their peers.

With your help in 2016, we hope to hold and build upon this momentum. It will be a year of capacity building for SCLC, and we continue to depend on your help. We continue to face the facts of a growing justice gap—particularly for those individuals who suffer from income stability, or are among King County's homeless population (which grew alarmingly in 2015.)



In 2016, SCLC has rebuilt a small, strong team, that conscientiously supports our social movement through case management, client representation, communication, and volunteer engagement. With two attorneys, one paralegal, and the help of many dedicated volunteers, we are serving more than 1000 people per year who have an urgent need for legal representation. Fueled by a thirst for justice, our team takes their work to the streets of Seattle through partnerships with community agencies (shelters and libraries,) and does so with personal vigor, conviction, patience, and grace. They take care of themselves and each other, and they build trust by observing and communicating with their clients each expectation and boundary they encounter. More than anything, they are fantastic advocates for justice, and the assemblage of this team has been SCLC's most important accomplishment of the past year.

When I became chair in 2015, SCLC had reaffirmed its commitment to supporting community members, and ensuring that people with physical and mental disabilities have access to financial stability.
